RULES AND REGULATIONS

- Anyone serving self-prepared foods and/or drinks must attach a copy of current permits required by state health regulations. Contact Guilford County Environmental Health directly (336-641-3771) to determine whether you need a permit and if so, the process to obtain it.
- The sale of sealed, commercially-prepared foods, canned drinks, bottled water, etc. does not require a permit from the Health Department. No food or drink shall be sold after its printed expiration date.
- No alcoholic beverages shall be sold.
- There is a \$100 fee to be a vendor for the Independence Day Celebration 2020 event. Please submit this completed form, a copy of any required permits for selling food and/or drinks, and a check payable to “Town of Pleasant Garden” to the Town Clerk no later than May 22, 2020. Spaces are limited. The Town reserves the right to restrict the number of vendors.
- Please attach a Certificate of Liability Insurance with the Town named as an additional insured, with a \$1 million general liability coverage.
- No water or electricity is available for vendor use. Vendors must supply their own tables, tents, chairs, and generator if required for food prep, etc. which shall be placed only in areas designated by town staff. Vendors are responsible for cleaning up their immediate area and for removing their garbage from the site.
- Vendors must have the ability to accept credit and debit card payments.
- Vendors cooking at this event with electricity or propane are required to have a fire extinguisher onsite as requested by the Pleasant Garden Fire Department.

**** HOLD HARMLESS, GENERAL RELEASE, AND RULES AND REGULATIONS AGREEMENT ****

In consideration of the Town of Pleasant Garden’s (hereinafter the “Town”) permission to sell food and/or drinks at the Town Event: Independence Day Celebration, I for myself, my heirs, executors and administrators, and all other firms, persons, and corporations hereby release, indemnify, and hold harmless the Town, its agents, officers, employees, servants and volunteers (hereinafter “agents”) from any and all responsibility or liability for any and all damage, injury or illness of any kind or nature whatsoever to all persons and to all property proximately caused by, incident to, resulting from, arising out of, or occurring in connection with, directly or indirectly, my participation as a vendor at the Independence Day Celebration, with the limited exception of harm caused by the sole negligence of agents of the Town. I acknowledge that I have read the above rules and will abide by them. I understand that if I have violated any regulations, Town officials may terminate my participation. I release the Town and its agents from any responsibility for theft, damage or loss in conjunction with any and all activities associated with my/my company’s vending at the event, with the sole exception of injuries occurring due to the sole negligence of agents of the Town.
