RULES AND REGULATIONS

- Handmade as well as vendor items are allowed at the event.
- No food, produce, or drinks shall be sold as a non-food vendor.
- Vendor must provide: table, chairs, canopy etc.
- No illegal or legal drugs, alcohol, or tobacco shall be sold, including CBD and other related products.
- No animals shall be sold.
- No items shall be sold that requires a permit, license, or certification.
- **Payment of \$45 per day** is required to the Town of Pleasant Garden to participate as a vendor. This form must be completed and submit to the Town Clerk at least three (3) days before the day you wish to participate along with a list of items you wish to sell at Town Recreation and Sports Events. Space at the fields is limited and the Town reserves the right to restrict the number of vendors.
- No water or electricity is available for Vendor use. Vendors must supply their own tables, tents, chairs, etc. which shall be placed only in areas designated by town staff. Vendors are responsible for cleaning up their immediate area and for removing their garbage from the site.

**** HOLD HARMLESS, GENERAL RELEASE, AND RULES AND REGULATIONS AGREEMENT ****

I acknowledge that I have read the above rules and will abide by them. I understand that if I have violated any regulations, Town officials may terminate my participation. I release the Town and its agents from any responsibility for theft, damage, or loss in conjunction with any and all activities associated with my/my company's vending at the Recreation and Sports Events, with the sole exception of injuries occurring due to the sole negligence of agents of the Town.
